ILLINOIS STATE FIRE MARSHAL RECEIVES \$1,000,000 SMALL EQUIPMENT GRANT



The Office of the State Fire Marshal (OSFM) has been appropriated \$1,000,000 for the State of Illinois Small Equipment Grant Program. The purpose of this program is to provide grants directly to local units of government for the purchase of small equipment by a fire department, fire protection district or township fire department. These grants may not exceed \$26,000 to any fire department or fire protection district.

The open application period started Friday, August 1, 2014 and ends Tuesday, September 30, 2014. An application is required plus W-9 forms.

Please note: The NFIRS requirement has changed as stated on the application. When downloading the application you will find examples of the NFIRS requirement (Monthly Incident Counts Report) for your reference. These reports are required as an addition to the application. Fire Prevention Week was established to commemorate the Great Chicago Fire, the tragic 1871 conflagration that killed more than 250 people, left 100,000 homeless, destroyed more than 17,400 structures and burned more than 2,000 acres. The fire began on

October 8, but continued into and did most of its damage on October 9, 1871.





Governor Quinn Fights for Stronger Gun Laws Across Illinois



CHICAGO – July 13, 2014, Governor Pat Quinn, joined by Congresswoman Robin Kelly, today visited the site of a recent fatal shooting in Chicago's Morgan Park neighborhood to urge legislators to stand with families and communities and take action against gun violence. The Governor pushed passage of the Illinois Public Safety Act, legislation that would ban the sale or delivery of assault weapons and high capacity ammunition magazines in Illinois and require background checks for the transfer of guns. Today's action is part of Governor Quinn's agenda to make Illinois neighborhoods safer.

"The recent epidemic of violence in Chicago is unacceptable and we must join together to fight back," Governor Quinn said. "Public safety is government's foremost mission and Illinois should not wait any longer to act. There are too many victims of a war being waged on our streets, a war fueled in part by the availability of deadly, military-style assault weapons that have no purpose other than killing.

"We must work together to protect the lives of those we love and stop what's happening in our communities. I urge the Illinois General Assembly to take a stand and pass this legislation that will save lives and protect communities."

The Governor today was joined by Congresswoman Robin Kelly who recently released the Kelly Report on Gun Violence in America, the first-ever Congressional analysis of the nation's gun violence epidemic that offers a blueprint for ending the crisis.

Senate Bill 3659 – the Illinois Public Safety Act – was introduced during the recent spring Legislative session by State Senator Dan Kotowski (D-Park Ridge) and supported by Governor Quinn. It bans the possession, delivery, sale and purchase of assault weapons, large capacity ammunition feeding devices such as magazines or clips, and .50 caliber rifles and cartridges in Illinois. Valid Firearms Owners Identification Card (FOID) holders who possess any of these devices at the time the law is enacted would be allowed to keep them, but could not transfer or sell them except to a family member. The legislation also requires background checks for the transfer of firearms except to a family member or at a gun show.

A review of mass shootings between January 2009 and January 2013 by Mayors Against Illegal Guns found that incidents where assault weapons or large capacity ammunition magazines were used resulted in 135% more people shot and 57% more killed, compared to other mass shootings.

"This is a common-sense solution to preventing gun violence and keeping our children and families safe," Senator Kotowski said. "This measure will protect our communities by ensuring that military-style assault weapons are off the streets and out of hands of criminals."

Governor Quinn has long fought to protect Illinois neighbor-

hoods from gun violence. He signed legislation in 2013 that increases penalties on gun owners who don't report the theft or loss of a weapon. This major legislation was a key priority in the Governor's 2013 State of the State address. He also signed a law in 2011 to increase penalties for convicted felons who are found carrying guns – this helps fight gun crime in Illinois by ensuring that felons who are convicted of new weapons offenses will be sent to prison and not allowed to walk the streets of Illinois. Governor Quinn also signed a law in 2009 establishing mandatory prison time for gang members convicted of possessing a loaded gun in a public area.

Seven states and the District of Columbia have enacted laws banning assault weapons: California, Connecticut, Hawaii, Maryland, Massachusetts, New Jersey and New York. In addition, Minnesota and Virginia regulate assault weapons.

Purple Heart

The Purple Heart Medal is presented to Illinois State Police personnel who, while in the performance of enforcement duties, are seriously injured or killed while encountering deadly force. Receiving the Purple Heart this year is Trooper James M. Sauter.

On March 29, 2013, **Trooper James M. Sauter** was on duty in his ISP squad car when his vehicle was struck by a truck tractor semitrailer at I-294 southbound at Willow Road. He was pronounced dead at the scene early Friday morning and had been a member of the Illinois State Police since June 29, 2008. Trooper Sauter had just completed a temporary assignment in Air Operations and was recently reassigned to District 15 as a patrolman.

Lifesaving Medal

The Lifesaving Medal is awarded to Illinois State Police personnel who perform actions or who apply techniques that result in saving or sustaining a human life.

WORK ZONE TRAFFIC SAFETY

WHO IS AT RISK: Each year AFSCME members die or are seriously injured when ROAD vehicles crash through traffic control devices WORK and enter a work zone. Workers are also struck by equipment operating within the work AHEAD area. Repairing streets and bridges, cleaning catch basins, and rebuilding manholes are examples of tasks that require workers to share the road with other vehicles.

PREVENTION: A traffic control plan must be developed BE-FORE the work begins to guide drivers through/around work zones.

A traffic control plan should include:

- Advance warning to drivers of road work ahead,
- Traffic control devices to clearly mark the work zone and channel traffic through it, and Returning traffic to normal traffic patterns as quickly, safely and efficiently as possible.

A traffic control plan needs to address these factors:

- Type of roadway (number of lanes, divided or undivided highway, etc.),
- Volume and speed of traffic (the number and speed of cars, trucks, etc.),
- Type of job and how long it will last, and
- Type and number of traffic control signs and devices.

Detours: Closing roads and re-routing traffic away from the maintenance activities puts a safe distance between workers and traffic.

Barriers: Concrete barriers, also called Jersey barriers or K-rails, separate workers from traffic. They are used for long-term projects such as during road construction and bridge deck replacement. Concrete barriers are commonly used to temporarily change stretches of 4-lane divided highways into two-lane roads.

Reducing the Speed Of Traffic In Work Zones

- Methods to slow traffic in work zones include:
- Driving pilot cars at reduced speeds to slow traffic,
- Portable rumble strips on roadways,
- Portable radar units mounted on construction vehicles,
- Aggressively enforcing speed limits in work zones,
- Doubling the fines and/or points charged against a driver's record for speeding.

Advance Warning Signs: Signs should be located far enough in advance of the work area to allow vehicles to move smoothly and efficiently around work areas. They must clearly inform motorists of approaching activity and guide drivers around or through the activity.

All advance warning signs must be:

- orange background with black lettering or symbols,
- retro-reflective or illuminated if used when it is dark,
- 4 feet by 4 feet if traffic moves at 45 miles per hour or faster,
- 3 feet by 3 feet if speeds are 40 mph or lower,
- 7 feet above the road surface (measured to bottom of sign),
- at least 1 foot above the road surface if the sign is portable,
- less than 50 percent of the top two rails or not more than 33 percent of all rails if mounted on a barricade.

Advance warning signs should be placed so as to give motorists enough time to react to the conditions they will find ahead of them. In general, the distance between the first warning sign and the work area should be increased the faster that traffic is moving.

2012 WORK ZONE FATALITIES

Illinois ranked 6th in work zone fatalities at 19, and 10th in total traffic fatalities with 956. The top three states with the worse record of fatalities is: Texas, 3398 total fatalities, 125 work zone related. California, 2857 total fatalities, 67 work zone related. Florida, 2373 total fatalities, 51 work zone related. Rhode Island and Alaska hold the title of the least fatalities, both having zero work zone fatalities.
